- 4. Start date of December 19, 2022.
- 5. Pending the results of a drug and alcohol pre-employment testing and all other preemployment requirements.

Eric Smith seconded the motion. Roll call: Van Buren YES, Smith YES and Foor YES. The motion passed.

-Eric Smith moved to hire Hunter Skaggs with the following details:

- 1. \$24.00 per hour rate of pay, train to fill road worker position.
- 2. Six-month probation.
- 3. One (1) week of vacation in the first year of employment, after the six-month probation period.
- 4. Three (3) weeks' vacation after one (1) year of continuous service.
- 5. Start date of October 1, 2022.
- 6. Pending the results of a drug and alcohol pre-employment testing and all other preemployment requirements.
