Road Report – Pete Sigman, Road Superintendent

Pete reported that the shelter house repairs are to start around Sept. 1st.

New tires have been installed on the mowing tractor and are working fine.

Tree King will have the cemetery tree project completed by the end of August. While meeting with Tree King, Pete discussed the tree canopy (over the roadway) at 4710 Gale Road. He will look at other tree problem areas within the township and combine those for a more inclusive project in the future. Pete will work on acquiring estimates.

Pete would like to meet with the Licking County Engineer in the near future. He has reached out to them, but not been contacted yet. Trustee Van Buren will speak with them this week to arrange for a meeting.

Pete has been discussing the sign replacements, within Lexington Woods. The township will replace the faded signs with similar signage.

Pete discussed rehabbing the salt barn next year.

The 2024 paving project was discussed. The trustees hope to utilize grant money for this project.

-Mark Van Buren moved to create a P.O. with ACE Truck for \$15,000.00 for repairs and maintenance on road department equipment. Eric Smith seconded the motion. Roll call: Van Buren YES, Smith YES, and Foor ABSENT. The motion passed.

Zoning Report -Valerie Hans, Zoning Inspector Valerie indicated that the nuisance grass at 0 Columbus Road was still unresolved.

Valerie indicated that the property at 40 Cherokee Trail had grass and debris on it.

-Mark Van Buren moved to adopt Resolution 2023 08 07 02 which states: RESOLUTION TO DECLARE AND ABATE NUISANCE OHIO REVISED CODE SECTION 505.87, 40 Cherokee Trail, Granville. Eric Smith seconded the motion. Roll call: Van Buren YES, Smith Yes, Foor ABSENT. The resolution was adopted.

3976 York Road has been mowed. No further action necessary, at this time. 4874 National Road: Dan Kreager has visited the site. The zoning inspector is awaiting the report from his visit.

Trustees-Discussion took place regarding the latest BZA hearing. The trustees inquired about the hearing and discussion during that matter.
