The Harrison Township Trustees met in regular session on June 2, 2025 at the Township Hall. The Chairman, Mark Van Buren, called the meeting to order at 6:00 p.m. and lead those present in the Pledge of Allegiance. From the floor - Bryce Ramsay, Assistant Prosecuting Attorney

Mr. Ramsay is a Licking County Assistant Prosecuting Attorney that has been assigned to Harrison Township. Carolyn Carnes introduced him to Harrison Township.

From the floor – Constance Caruso, 6463 Blacks Road

Ms. Caruso lives one half mile east of York Road along the railroad tracks. She is concerned with the train blowing its whistle for the last year. She has contacted the railroad and it continues. Trustee Van Buren stated that the township has no power over the railroad and that she could contact the railroad or the Ohio Rail Commission. Ms. Caruso inquired if the Assistant Prosecutor could help and they had the same suggestions as Trustee Van Buren.

From the floor – Robert Turberrille, 255 Hillgail

Mr. Turberrille lives in Beechwood Trails. He is concerned with solicitors coming door to door. He stated that elderly residents are very upset and that no wants what they are selling. Trustee Van Buren stated that Bryce Ramsay, Assistant Prosecuting Attorney will look into this matter.

From the floor – Linda Kretzmann and Melissa Anderson Linda Kretzmann introduced Mellissa Anderson and both were with the Licking County Coalition of Care. The Ruff Checkbook Program, supported by the John A. and Dorothy E. Ruff Fund of the Licking County Foundation, was established to address the temporary needs of residents of Harrison Township in Licking County. The program provides food, clothing, financial assistance for shelter and, in other ways, meets the basic needs of residents of the township who are experiencing a hardship in an emergency.

Road Report – Pete Sigman, Road Superintendent

Pete reported that the F-600 pickup from Coughlin Ford is ready to pick up. Pete reviewed the inventory list and came up with a closer value of the road department shop contents for the insurance renewal. OTARMA has not had sufficient time to get us a new quote. The fiscal officer recommended approving a purchase order from the original quote for the township insurance since the renewal is effective June 16th.

-Eric Smith moved to approve a purchase order to OTARMA in the amount of \$19,852.00 for the township renewal insurance policy. Ray Foor seconded the motion. Roll call: Van Buren YES, Smith YES and Foor YES. The motion passed.

Pete reported that the first round of roadside mowing is nearly complete. Pete stated that he receives drainage complaints daily. Many of the problems are from the volume of rain that has been received this spring.

Zoning Report – Valerie Hans, Zoning Inspector

- ➤ The zoning permit and fee total for May was \$1,415.90.
- Edward J. Stiles Parcels Cleanup is moving slower than expected due to extremely wet conditions.
- > 4765 National Road The trustees will consult with the Prosecutor.
- > 28 Donau Road The Prosecutor is working on the case.
- 150 Madison Street, 46 Nashua Court, 31 Buick Avenue and 201 Riva Ridge all have nuisance violations but no clean up quotes have been received.
- > 110 Ford Avenue Rice High grass violation, requested first resolution.
