## BOARD OF TRUSTEES OF HARRISON TOWNSHIP LICKING COUNTY, OHIO MINUTES OF REGULAR MEETING JULY 22, 2025

The Harrison Township Trustees met in regular session on July 22, 2025 at the Township Hall. The Chairman, Mark Van Buren, called the meeting to order at 9:00 a.m. and lead those present in the Pledge of Allegiance. The Fiscal Officer called the roll, and the following members and guests were present. Trustee Eric Smith was absent.

From the floor – Ronald Sharpe, 467 Apple Blossom Road

Mr. Sharpe stated that around April 4, 2024, after a two day rain, his basement flooded causing damage. He would like for the trustees to request an engineering study by the county to evaluate and enlarge the culvert under Apple Blossom Road SW to a capacity large enough to prevent recurrence. The Road Superintendent stated that the culvert is a twenty-four inch oval shaped galvanized culvert. He also stated that the stream is on private property and the township cannot touch that area.

-Mark Van Buren moved to request the Licking County Engineer to study the culvert size on Apple Blossom Road. Ray Foor seconded the motion. Roll call: Van Buren YES, Smith ABSENT and Foor YES. The motion passed.

Road Report – Pete Sigman, Road Superintendent

- -Pete reported that Pavement Technology has finished Reclamite application. The project went smoothly and looks good. The lines on the roads will brighten as rain washes the product off.
- -A few aged boards on the train depot porch have been replaced. Pete suggested replacing the porch next summer.
- -Pete reviewed repairs for the 310 JD backhoe and the 6230 JD tractor and the cost.
- -Pete reported some potholes on Wesleyan Church, Hollow and Refugee as well as spiderweb cracking in Beechwood Trails as well as road damage on Lake Drive. The road crew will exercise the dura patcher to correct those issues.
- -Pete reviewed the EPA audit for the MS4 group.

Trustee Van Buren stated that a donation agreement between Harrison Township and the Village of Kirkersville has been prepared by the Licking County Prosecutors office. The Village of Kirkersville plans to donate \$10,000.00 to the Township as a contribution to the Keller Road Resurfacing Project. The Agreement needs to be signed.

The special meeting will start at 9:00 a.m. The purpose of the meeting is to open The Resurfacing of Keller Road in Harrison Township bid packets and award the contract, approve meeting minutes and bills and review and sign an IGA for a Donation Agreement between Harrison Township and the Village of Kirkersville.
