# BOARD OF TRUSTEES OF HARRISON TOWNSHIP LICKING COUNTY, OHIO MINUTES OF REGULAR MEETING SEPTEMBER 2, 2025

The Harrison Township Trustees met in regular session on September 2, 2025 at the Township Hall. The Chairman, Mark Van Buren, called the meeting to order at 6:00 p.m. and lead those present in the Pledge of Allegiance. The Fiscal Officer called the roll, and the following members and guests were present.

From the floor – Todd Troutman, 6565 Outville Road SW

Mr. Troutman is concerned about someone living in a car near his property at 6623 Outville Road. Especially with the day care business that is coming soon. He is concerned for the elderly gentleman that owns the property. There is no identity of this person and he is concerned for everyone's safety.

The Zoning Inspector stated that the trustees are aware of the situation and that several violation notices have been issued. She is ready to ask the Licking County Prosecutor for assistance with this matter.

From the floor – Mike Leitwein, 51 Ohio Ave. SW

Mr. Leitwein's property at 51 Ohio Ave., SW has been cited for a nuisance violation.

He attended the meeting to let the trustees know that he has been cleaning up and selling items on the market place. He has been sick and waiting to see a doctor, he only feels good two days of the week. He feels that his property is good.

The Zoning Inspector stated that there has not been much progress. Mr. Leitwein stated that he has moved six motorcycles and power washers. The Zoning Inspector stated that this has been going on since 2020. Trustee Van Buren ask Mr. Leitwein how long does he need to clean up. Time would be granted before moving forward with a forced cleanup by the township. Basically Mr. Leitwein stated that it is pretty good, he has been working on it and the township can take him to court.

Road Report – Pete Sigman, Road Superintendent
Pete reported that the ODOT Rock Salt (Sodium Chloride) Contract has been awarded.
Licking County and Harrison Township will have Cargill, Inc. as a vendor. The price is \$75.12 per ton and the township requested 400 tons.

-Eric Smith moved to approve a purchase order to Cargill, Inc. in the amount of \$37,500.00 to cover the ODOT Rock Salt Contract 018-26 for the 2025-2026 winter season. The price is \$75.12 per ton. Ray Foor seconded the motion. Roll call: Van Buren YES, Smith YES and Foor YES. The motion passed.

Pete reported that the culvert at Refugee Road west of Outville needs to be replaced instead of repaired as was discussed at the last meeting.

-Eric Smith moved to request engineering from the Licking County Engineer for replacing the culvert at Refugee Road west of Outville. Ray Foor seconded the motion. Roll call: Van Buren YES, Smith YES and Foor YES. The motion passed.

Pete reported that he had no news on the Keller Road Resurfacing Project and that Strawser has completed the crack seal project.

Pete reported that birds have chewed a hole in the soffit of the historical township hall at the township complex. The trustees would like for him to cover the hole.

Joy McClain called from the Lexington Woods HOA and told Pete that the light poles need work and ask for a contractor recommendation. No one had a recommendation to share.

Zoning Report – Valerie Hans, Zoning Inspector

- The Zoning Inspector reported on the following items.
- The zoning permit and fee total for August was \$2,139.80.
- Edward Stiles Parcels Crispin's has hauled out 26 loads of nuisance debris and vehicles so far at this site for a total of 101,000 lbs. of material. Tear down/removal of the trailer will begin on September 4<sup>th</sup>.
- 28 Donau Road Kretzmann The Licking County Prosecutor has sent a follow up letter to Mr. Kretzmann announcing intent to file litigation. Violation is a second dwelling established on the property.
- ➤ 6623 Outville Road Williams Second dwelling units have been established in a vehicle and now in a shed on the property. No improvement with this situation.

- ➤ 138 Ford Ave. Thomas Junk motor vehicles still on property. Will give them more time.
- The BZA met on 8/20/2025 to consider two applications. One for a conditional use to operate a daycare at 6621 Outville Road which was approved with conditions. The second application for variance to split a lot with less than the required 100 feet of road frontage in an R-15 district was denied. The BZA met again on 8/22/2025 to approve the minutes of the 8/20/2025 public hearing. The BZA also asked to schedule another public hearing for 9/16/2025 to reconsider the application that was denied. The trustees were very concerned with the fact that the BZA is holding a reconsideration public hearing once the application was denied. The Zoning Inspector stated that additional information was brought to her by the applicant. The Zoning Inspector could not share any other details since the topic was discussed in executive session at the BZA public hearing. The trustees stated that this information should have been presented at the public hearing. The trustees clearly stated that in no way do they want to change or influence anything that the BZA does. They are their own independent board making their own decisions independent of the Board of Trustees. The Zoning Inspector is working with the Licking County Prosecutor on this matter.
- ➤ 180 Cadillac Ave. and 200 Cadillac Ave. Both properties were sent swimming pool violation notices last month and failed to respond. The Zoning Inspector requested assistance from the Licking County Prosecutor.

-Ray Foor moved to request assistance from the Licking County Prosecutor for swimming pool violations at 180 Cadillac Ave. and 200 Cadillac Ave. Eric Smith seconded the motion. Roll call: Van Buren YES, Smith YES and Foor YES. The motion passed.

-Eric Smith moved to approve the following:

Trustee Van Buren reported that a meeting with the developer of Scenic View has been set for September 29<sup>th</sup>.

6:58 p.m. – The trustees interviewed Lee Morgan for the road worker position.

7:13 p.m. – The trustees interviewed Michael Ward for the road worker position.

Candidates Joel Smith and Jared Graffius were unable to attend for their scheduled interview.

The fiscal officer shared a notice to legislative authority from the Department of Commerce, Division of Liquor Control. The letter stated that DOLGEN MIDWEST LLC, Dollar General Store 30557, 10 Ephriam Drive SW, Granville, Ohio 43023 has applied for a C-2 C-1 liquor permit. The permit number is 02234815-728.

The trustees have the option to request a hearing on the advisability of issuing the permit and request that a hearing be held or not request a hearing. The trustees felt that residents should have the ability to express their opinions.

-Eric Smith moved to request a hearing on the advisability of issuing the liquor permit and request that the hearing be held in our county seat. This is a request for DOLGEN MIDWEST LLC, Dollar General Store 30557, 10 Ephriam Drive SW, Granville, Ohio 43023 applying for a liquor permit. Discussion: The trustees are not for or against the liquor permit application. They felt that a hearing would give residents the ability to express their opinions if they wish to do so. Ray Foor seconded the motion. Roll call: Van Buren YES, Smith YES and Foor YES. The motion passed.

-Eric Smith moved to request an amended certificate from the Licking County Auditor. Listed are the updates to the revenue budget.

Ray Foor seconded the motion. Discussion: NO APPROPRIATIONS WERE CHANGED. Roll call: Van Buren YES, Smith YES and Foor YES. The motion passed.

The fiscal officer reported that the Auditor of State has released Bulletin 2025-007, Adoption of Cybersecurity Program. Trustee Van Buren stated that the OTA is in the process of developing a policy for townships.

-Eric Smith moved to approve blanket purchase orders for the following:

Outville Street Lights electric in the amount of \$1,200.00.

Indian Hills Street Lights electric in the amount of \$1,200.00.

Ray Foor seconded the motion. Roll call: Van Buren YES, Smith YES and Foor YES. The motion passed.

The fiscal officer shared Schedule A and B which is a summary of amounts required from general property tax approved by the Budget Commission and the County Auditor's estimated tax rates for tax year 2025 collected in 2026.

Harrison Township is estimated to receive \$211,474.00 from a one mill Road & Bridge Levy, \$426,354.00 from a two mill Road & Bridge Levy as well as \$1,357,606.00 from the inside 10 mill limitation for a total of \$1,995,434.00.

-Eric Smith moved to adopt Resolution 2025 09 02 06 which states: Resolution Accepting the Amounts and Rates as Determined by the Budget Commission and Authorizing the necessary Tax Levies and Certifying them to the County Auditor. Ray Foor seconded the motion. Roll call: Van Buren YES, Smith YES and Foor YES. The resolution was adopted.

The fiscal officer reported that Rumpke has furnished their Performance Bond for the contract period 10/1/2025 - 9/30/2026.

The trustees discussed the two applicants that were interviewed earlier during the meeting. They were impressed with both candidates. The concern with Michael Ward is the fact that he would need six weeks to obtain the necessary CDL.

-Eric Smith moved to hire Lee Morgan to fill the road worker position for Harrison Township. He will be paid \$28.00 per hour. This position is pending pre-employment testing. Ray Foor seconded the motion. Roll call: Van Buren YES, Smith YES and Foor YES. The motion passed.

-Ray Foor moved to raise Terry Perkins, current road worker, hourly pay from \$26.60 per hour to \$29.00 per hour, effective at the beginning of the pay period that follows the effective date of the approved change, as per employee handbook. Eric Smith seconded the motion. Roll call: Van Buren YES, Smith YES and Foor YES. The motion passed.

The fiscal officer read various pieces of correspondence and passed out Financial Reports for the trustees to review.

Being no further business, Chairman Mark Van Buren adjourned the meeting at 8:00 p.m. Minutes are unofficial until approved by the trustees.
