## HARRISON TOWNSHIP PARK RULES & REGULATIONS

- 1) Shelter reservations must be filed with the zoning office at least seven business days in advance of the date requested.
- 2) Persons reserving shelter house must be 18 years old and a resident of Harrison Township.
- 3) The person making the reservation will be held responsible for their groups' conduct and will be responsible for payment to cover any damages.
- 4) Alcoholic beverages are prohibited anywhere in the park. Parties possessing alcoholic beverages will be required to leave premises immediately.
- 5) All trash and recycling from the event you are hosting needs to be cleaned up and placed in trash cans or removed from the park at the end of the reservation time.
- 6) Shelter house #1 has 9 picnic tables.  
Shelter house #2 (near the playground) has 6 picnic tables.  
If picnic tables are moved from one shelter house to another during your reservation, they must be moved back prior to exiting the premises.
