MINUTES OF PUBLIC HEARING SEPTEMBER 6, 2022

The Harrison Township Trustees held a public hearing on September 6, 2022 at the Township Hall. The Chairman, Mark Van Buren, called the public hearing to order at 6:34 p.m. and read the purpose of the public hearing. Notice is hereby given, pursuant to the provisions of Ohio Revised Code (R.C.) Sections 715.72 through 715.81, that the Harrison Township Board of Trustees, Licking County, Ohio will hold a public hearing on September 6, 2022, at 6:30 p.m. at the Harrison Township Hall located at 6750 Outville Road, Pataskala, Ohio. The purpose of the public hearing will be to hear public comment on amendment and expansion of the Joint Economic Development District with the City of Newark and the City of Pataskala, Licking County, Ohio, which district is designated Pataskala Corporate Park Joint Economic Development District. The proposed contract amendment for said Joint Economic Development District with exhibits thereto, and all other documentation required by law, are available to the public at the office of the Harrison Township Fiscal Officer, 6750 Outville Road, Pataskala, Ohio, during normal business hours in accordance with R.C. 715.75.

The public hearing shall be for the further purpose of allowing public comment and recommendation on the second amendment to the contract creating the district expansion in accordance with the provisions of R.C. 715.761.
